(TEMPORARY PROHIBITION OF PEDESTRIANS, CYCLISTS AND HORSE RIDERS)

(BRIDLEWAY NO. 503002 (part), BARBON) ORDER 2019 No. 1

Road Traffic Regulation Act 1984 – Section 14(1) (as amended)

Notice is hereby given that the above Order made by the Yorkshire Dales National Park Authority on 22 January, 2019, the effect of which is to prohibit any pedestrian, cyclist and horse traffic from proceeding along part of Bridleway No. 503002 from the point of closure at Grid Reference SD 6357 8260 for a distance of approximately 1.15 km to the point of closure at Grid Reference SD 6469 8275 in the Parish of Barbon in the district of South Lakeland from 1 February, 2019 until 2 August, 2019 inclusive, due to forestry works being executed on or near the route, has been continued in force under Section 15(5) of the above Act, with the approval of the Secretary of State for Transport, Local Government and the Regions for a period of 6 months until 2 February, 2020 or until the completion of the works whichever is earlier.

The closure will be continued in effect by the erection of notices and signs.

The alternative route to be used during the closure period will be as follows:-

From point of closure at Grid Reference SD 6357 8260 follow the Bridleway in a westerly direction through Barbon Park to the entrance to Oak Tree Farm and county road, bearing south for approximately 178 metres before turning easterly to follow the county road through the village, past the church and in the direction of Dent for approximately 3.2 km to re-join the bridleway at the ford and footbridge over Barbon Beck, from here continuing in a westerly direction to the eastern side of the woodland area and point of closure at Grid Reference SD 6469 8275 and return.

Pedestrians can follow the footpath link between Barbon Park GR SD 6317 8262 and Barbon Church at SD 6307 8242 to re-join the county road, (shown as X-Y on the site plans).
