

<u>L2 Conversion of traditional buildings – acceptable uses</u>

.....change of use of traditional buildings will..... <u>be</u>

<u>permitted within existing settlements and building groups or other suitable roadside locations.</u>

.....Proposals for change of use to a dwellinghouse for continuous occupation will be subject to a local occupancy restriction


<u>Aim</u>


5.8 To allow traditional buildings to be put to alternative uses where the building and its location is able to accommodate the intensity of the new use and associated impacts.

Policy L2 (conversions)




- a significant expansion of local planning policy
- Intensive residential uses are now permitted for 'roadside' barns
- Buildings must have physical capacity for domestic use without significant alteration or extension
- 'Roadside' excludes buildings that are not in close proximity to a road or track ie. isolated 'field' barns
- Field barns and other isolated traditional buildings may be permissible for other less intensive uses that do not need direct vehicular access or parking eg. barn 'pods', storage, camping barns etc.

FARMING OBJECTIVE

- 1. Maintain or increase the number of viable farm businesses
- 2. Take advantage of Brexit opportunities

Rembering:

Farmers are the Dales' biggest asset.

CURRENT SITUATION

Agri-Food Chain

- Contributed £109 billion GVA (7.3%)
- Agriculture & fishing contributed £11 billion GVA (0.7%)
- 3.9m people employed (14% of national employment)
 - Agriculture 500k (13%) nationally, 2k in YDNP

CURRENT SITUATION

YDNP farmers

- Support of £30k to £60k;
- Family income of £10k to £20k;
- Also some receiving family credit;
- Spouse's contribution

DEFRA'S VIEW

- Direct payments are a significant proportion of farmers' total income;
- In 2014/15 half of the farmers in England failed to cover their costs of production;
- Even after all support payments are included in farm revenue, almost 20% of farms failed to achieve a farm business income;
- Increase in the budget for support of Pillar II objectives, such as the provision of public goods;
- Farmers in England would most likely receive lower, perhaps no, direct payments;
- "We are committed to being the first generation to leave the natural environment of England in a better state than that in which we found it"

OTHER VIEWS

• CLA

 The core of this policy should be multiannual contracts between the government and land managers supporting them in the provision of a wide range of, primarily but not exclusively, environmental public goods.

National Trust

 We want to see increased benefits to the public in the form of a beautiful, natural environment, rich in nature and wildlife, and the land, on which our farming depends, secure in its long term health and productive capacity.

OTHER VIEWS

• NFU

- The natural environment is much wider than biodiversity.
- Environmental delivery should not be seen in isolation of our production or our use of the countryside for food production.
- In future, environmental delivery outside of Europe will be shaped by the trade agreements put in place.

OTHER VIEWS

Dieter Helm (Independent Chair of the Natural Capital Committee)

- There is also a powerful argument that small upland farmers represent a culture that has value separate from the narrow economic outputs. They play a role in communities greatly in excess of their incomes and spending. Uplands given over to tourism would also not work without the management of the land.
- The upland farmers have a key role in managing the land. Someone has to do it for the public benefit, and upland farmers tend to be rooted in these landscapes and understand them in a way that few from outside do. These are the marginal farmers, and the ones who are most dependent on subsidy.

WHAT IS THE FUTURE?

- Uncertain;
- So making decisions is difficult;
- It is likely that the YDNPA and the YDNP farmers will have to show:
 - Value for money;
 - Significant environmental influence;
 - Public money for public goods in some form.

WHAT NEXT

1. Do nothing and hope funding levels stay as they are;

Plan for:

- 2. BPS maintained with a reduction of 10 to 20%;
- 3. BPS maintained with a reduction of 30%;
- 4. Pillar 1 & 2 to be merged and for the uplands to maintain current levels of funding;
- 5. Pillar 1 & 2 to be merged and for the uplands to lose 10 to 20% support.

Statutory provisions



 Conserve and enhance the natural beauty, wildlife and cultural heritage;

 Promote opportunities for the understanding and enjoyment of the special qualities by the public

Statutory provisions



- Underpinned by 'Sandford principle'
 - Conservation takes precedence if there is irreconcilable conflict;
- 'Section 61 duty'
 - In pursuing the purposes, must seek to foster the economic and social well-being of local communities.
- National Park Circular (2010)

Other statutory provisions



- Natural Environment and Rural Communities Act 2006
- Countryside and Rights of Way Act 2000
- Town and Country Planning Act 1990
- Planning and Compulsory Purchase Act (2004)
- National Planning Policy Framework
- European Landscape Convention

Delivering conservation



- National Park Management Plan
 - Grants to farmers and landowners;
 - Advice and help to get other grants;
 - Planning policy and implementation;
 - Major projects (e.g. Ingleborough Dales)
 - Managing access;
 - Supporting communities and volunteers
 - Raising awareness/education
 - Research and survey

SDF facts and figures



- Operated for 15 years
- £2.3 million to 272 projects
- £175,000 available this year
- Over £80,000 given to 11 projects so far this year

What's it for?



- To support projects that result in positive benefits for the Yorkshire Dales National Park:
 - its environment; and,
 - its economy; and,
 - its communities.

Eligibility



- Contributes to National Park Purposes:
 - Natural beauty, wildlife, cultural heritage; or
 - Understanding and enjoyment by the public

And

 Provides some local economic benefit or some benefit to a local community

How much can you apply for?



No minimum or maximum grant

Aim to support 15-20 projects a year

 Up to 75% of costs for charities or community groups

Up to 50% of costs for all other applicants
