1. CHAIRMAN'S INTRODUCTION

Welcome to this the second Annual Report of the Yorkshire Dales Access Forum. Over the last year the Forum has continued to develop and mature. I hope that you find reading this report interesting and enlightening.

Again most of the Forum's work has centred around the Countryside and Rights of Way Act and in particular the implementation of Open Access for recreation on foot. In our area the Upper North West dedication is now due for May 2005. The Yorkshire Dales National Park Authority has been working hard to ensure smooth implementation, with the Forum being consulted and advising on a wide range of matters, which we have welcomed. For some Open Access is a dream that has been hard won, whilst for others there are still very real and understandable concerns. I hope the Forum is capable of understanding all these feelings and issues, especially as we start the challenging role of advising on long term exclusion and restriction applications.

Work has now started on the drawing up of Rights of Way Improvement Plans by both Cumbria and North Yorkshire County Councils, with the Forum represented and giving its views on the various working groups and parties. This will become a major area of work for us in the next year and it is part of our responsibility to ensure that a balanced Yorkshire Dales perspective is included in these county-wide plans.

The next year will see the Forum expanding its role further, looking at issues relating to all aspects of recreational access within the Yorkshire Dales. This will mean making our voice heard by pointing out opportunities, highlighting concerns and challenging decisions.

Public attendance at our meetings continues to grow and we have welcomed the issues raised by members of the public during the last year. If you have a matter that you feel we should address please bring it to my attention through the Access Development Officer of the National Park Authority.

In all of this we will continue to maintain our independent but friendly relationship with our Appointing Authority the Yorkshire Dales National Park. Their officers have worked tirelessly in the last year to support us. In particular I would like to thank Kathryn Beardmore and Rachel Mozley who have provided the lead officer support and secretariat that has ensured the smooth running of this Forum.

The major strength in any Local Access Forum is its members and we are lucky to have such a strong well balanced Forum with such a wide range of experience and knowledge to draw upon. Our members have been appointed as individuals with a keen love and interest in the Yorkshire Dales, rather than as specific representatives of land-owning or recreational organisations. Their breadth of expertise is our key strength and I would like to conclude by thanking them for their work, support, time and dedication over the last year.

2.1 The Role of the Yorkshire Dales Access Forum

It is the function of Yorkshire Dales Access Forum, in respect to the Yorkshire Dales National Park, to **advise** -

- (a) Yorkshire Dales National Park Authority (as the appointing authority), and the local highway authority for any part of the area,
- (b) any bodies exercising functions under CRoW Act Part 1 in relation to land in that area,
- (c) such other bodies as may be prescribed.

as to **the improvement of public access to land for the purposes of open air recreation and the enjoyment of the area, and as to such other matters as may be prescribed.** (CRoW Act s94(4)).

In consequence of the above the Yorkshire Dales Access Forum may comment on any aspect of the management of local access undertaken.

For example:

- advise the National Park Authority on any long term restrictions or exclusions on access land in its area;
- advise the National Park Authority on how public access to land in its area should be managed so as to reduce the impact of access on agriculture, conservation or land management, or to reduce the risk to public safety;
- advise on the means by which information to the public on access land, including restrictions and opportunities should be provided;
- make representations to the Planning Inspectorate during the course of any appeal brought by a person with a legal interest in the land; and
- advise the Secretary of State for Defence on any proposed restrictions on access on military training lands.

Yorkshire Dales Access Forum may be requested to provide advice on:

- strategies or plans incorporating recreation and access which set rights of way and open access in a broad context, integrating provision for access, all forms of open air recreation to land and water, and transport, tourism, health and public information for example the Integrated Access Strategy for the Yorkshire Dales National Park, and the Cumbria Countryside Access Strategy;
- the extent to which fair provision is made for all current and potential users, and reflects the needs of local people and businesses; and the co-ordinated use of resources to provide and manage integrated recreation and access, and the dissemination of information to interested groups and the wider public.

Yorkshire Dales Access Forum is a statutory consultee on the Rights of Way Improvement Plans being produced by Cumbria and North Yorkshire County Councils for the Yorkshire Dales National Park.

3. WHO ARE THE FORUM?

3.1 Members and representation

The Forum has been constituted so that:

- It is a balanced group, which avoids being dominated by single interests.
- It is representative of all interests, including; recreation use, land management, nature conservation, tourism, business, transport and access for all.

Many members have secondary interests as well as the primary interest for which they were appointed.

4. WHAT'S HAPPENED IN THIS LAST YEAR (JANUARY 2004 – MARCH 2005)?

4.1 Chairman of the Forum.

The Forum re-appointed Jon Beavan as Chairman and Benedict Heyes as Vice-Chairman at its first meeting of the year on 2 March 2004.

4.2 Formal meetings of the Forum

Four formal meetings have been held during this period. The dates and venues of these were:

- 2 March 2004 at the Maypole Inn, Long Preston.
- 29 June 2004 at the People's Hall, Sedbergh.
- 7 September 2004 at the Dales Countryside Museum, Hawes.
- 2 November 2004 at Craven District Council, Skipton.

4.3 Training and development

Three training events have been held for forum members during the reporting period:

- On 29 June 2004, Forum Members met with the Pennine Bridleway Project Officer, Gareth Evans, to look at the works being carried out on the Arten Gill section of the Pennine Bridleway.
- On 19 August 2004, Members of the Forum looked at some of the issues surrounding vehicular use of green lanes.
- On 4 February 2005, Steve Jenkinson facilitated a training event on the functions and role of the Forum.

4.4 Main Activities of the Forum.

At the March meeting, it was agreed to form a separate working group to look at how to deal with long term restrictions under Part 1 of the CROW Act. The group met twice in the reporting year.

Some Members of the Forum have attended meetings as a formal representative of the Forum. These meetings have included work on the Cumbria Access Strategy and the North Yorkshire Rights of Way Improvement Plan.

The Forum have responded to various consultations issued by DEFRA. For example, DEFRA Consultation on Section 42 of the CROW Act – The Forum agreed that regulations should be made in relation to the mines and quarries act. Responses to these consultations can be obtained from the Yorkshire Dales National Park Authority.

At the September meeting of the Forum, North Yorkshire County Council Officers facilitated a workshop on the Rights of Way Improvement Plan for North Yorkshire.

4.5 Advice of the Forum to the Authority

The Access for All sub-group presented a paper to be used by the National Park Authority, as the Forum's advice on issues, to be included in the production of an Access for All strategy.

With respect to byelaws, all members agreed that they were not needed for the management of open access in the Yorkshire Dales at the present time.

4.6 Formal Consultation

The Forum has been formally consulted on the following strategy documents:

- Integrated Access Strategy for the Yorkshire Dales National Park
- Cumbria Countryside Access Strategy

As well as applications where the National Park Authority was minded to make a direction of greater than six months to restrict or exclude public access under part 1 of the CROW Act. These were located at:

- Holgates Pasture, Kilnsey Moor
- Wood End, Hubberholme

Cases for consultation

Before giving a direction to restrict CROW access in the long-term (that is, for over 6 months or indefinitely), the relevant authority must publish on a website a consultation notice giving details of the proposed direction, and provide the public with an opportunity to comment.
